

Literacy Coalition Acquires Property for Literacy Center

Members of the Literacy Center Committee recently gathered at the site of the future home of the Literacy Coalition of Palm Beach County at 3651 Quantum Blvd. in Boynton Beach. The 12,204 sq. ft. Literacy Center for Education, Training and Outreach will serve as the hub for literacy services provided throughout Palm Beach County. A large training room will serve as the heart of the building and will help community volunteers learn how to be effective tutors. On-site services for the public will include homework help for children and one-to-one tutoring for adult learners. The anticipated project cost is \$3.5 million and the capital campaign has raised \$2.27 million from more than 300 donors. Ground breaking is anticipated as soon as all pledges are in place to fund the construction in its entirety. Naming opportunities are available throughout the building. Members of the Literacy Center Committee welcome the opportunity to meet with potential donors and provide details about the importance of this project to our community.







On October 6, 2011, more than 20,000 Palm Beach County children listened to Anna Dewdney's charming tale of "Ilama drama." The Literacy Coalition was proud to participate for the sixth year in Jumpstart's annual Read for the Record in which volunteers try to reach a world record for the number of children listening to a single story on the same day.

"This year Read for the Record generated more interest and

participation than before," said Darlene Kostrub, Chief Executive Officer of the Literacy Coalition of Palm Beach County.

The Literacy Coalition was pleased to offer readings at the Palm Beach Zoo by Mike Trim and Tania Rogers of WPTV NewsChannel 5, Craig Grant, Regional President of PNC Bank and Leslie Streeter of *The Palm Beach Post*. About 450 children piled into the zoo, many dressed in pajamas, to celebrate a morning dedicated to children's literacy. The Coalition is grateful to the Palm Beach Zoo for its partnership in offering a fun community event and even putting a llama on special exhibition for the children.

In addition to the zoo event, the Literacy Coalition placed 346 volunteers around the county in schools, libraries and at other public venues. The **League of Cities** held a competition for the widest participation by city leaders. **West Palm Beach** led the pack this year with 36 city officials reading at all the city's Parks and Recreation after school sites. **The Town of Haverhill** led the smaller municipalities with three city officials reading at five sites.



Literacy Coalition Board President Maggie Dickenson got into the spirit of the book.

"Watching the children so animated and enthusiastic when I read *Llama Llama Red Pajama* was not only a benefit to them but to me as well! I strongly encourage anyone with a love for children and learning to participate in this worthwhile cause," noted Lisa A Tropepe, League President.

Loxahatchee Groves Mayor Dave Browning and his wife Sharyn Browning read at Loxahatchee Groves Elementary School and Noah's Ark. "My wife got me dressed in red pajamas and I acted out the character. We had the children participate in the pouting and the yelling. When I yelled in character it startled them and they all laughed," Mayor Browning said. "We had a ball."

The Coalition is also grateful to our community partners who contribute

time every year. Kids look forward to a visit from Palm Beach County Fire and Rescue for Read for the Record. This year, they increased their county wide participation and at least seven different battalions read to more than 60 preschools. The Flagler Palm Beach Rotary Club participated for the third year in a row. Its volunteers had so much fun that they are considering reading three or four times throughout the year at their preschools! Velocity **Community Credit Union, Jupiter** Kiwanis Club and Jarden Consumer Solutions also once again contributed readers.

Lawyers were a particularly big support group this year. The Young Lawyers for Literacy had nearly 40 volunteers and the Office Depot Foundation's entire legal department volunteered!

Also, the Literacy Coalition was pleased that the **West Palm Beach Rotary Club** and the **Rotary Club of Lantana/Boynton Beach** participated for the first time this year.

Reach Out and Read Provides Pediatric Training



Trude Haecker, MD, will be the featured speaker at the annual training event on April 24 for the pediatricians participating in the Literacy Coalition's

Reach Out and Read Program. Dr. Haecker is a longtime Reach Out and Read (ROR) advocate and provider and currently serves as the Medical Director for Quality Improvement at the Children's Hospital of Philadelphia. She has experience implementing ROR at the local level and has been also involved in doing research in this area.

The Literacy Coalition implements the ROR national model at 28 local pediatric clinics that serve children and families in poverty. At each well child visit between the ages of six months and five years of age, children and parents receive literacy advice from their pediatrician as well as a new book to take home to share together. Reach Out and Read in Palm Beach County is made possible through funding from the Children's Services Council. National Parent-Child Home Office Certifies Local Program



In July 2009, the Literacy Coalition began enrolling families in The Parent-Child Home Program (PCHP), made available through the Children's

Services Council's Healthy Beginnings System of care.

The PCHP's national model is the country's most intensive home visiting program, providing at-risk families with two thirty-minute home sessions each week for two years. The program's two and three year old children receive books, toys or activities each week from a home visitor who role-models for the parent how to create verbalizations and engage with their child through the program's materials. Currently, PCHP works in more than 150 communities in 14 states, Bermuda, Canada and Ireland. In Palm Beach County, the Literacy Coalition is the lead agency for PCHP in which direct services to families are provided through four subcontracted agencies based upon the clients' language, ethnicity and/or geographical location.

These four agencies are ASPIRA of Florida, serving Hispanic families; The Guatemalan-Maya Center, serving Guatemalan and Maya families; Minority Development and Empowerment, Inc., serving African American and Haitian/Haitian American families; and Noah, Inc., serving The Glades.

This past October, the PCHP National Center conducted its first certification site visit at each of the Literacy Coalition's subcontracted agencies as part of the process of becoming an official replication site. Michele Morrison, Training and Program Support Director, and Cesar Zuniga, Research Director at the National Center, interviewed PCHP staff, reviewed systems and clients' files to measure the quality and fidelity of the program.

Following the visit, Michele Morrison wrote to the Children's Services Council's CEO, Tana Ebbole, "I wanted to let you know how impressed I am with the field practice I have seen and the enthusiasm and eloquence of all the PCHP (staff). As I mentioned to you, I believe that you have created a demonstration site for the state... I would like to commend the Literacy Coalition for their hard work in putting a countywide network of PCHP sites together and making the system work for so many families."

In November, the Literacy Coalition received word that the Palm Beach County PCHP has been officially certified as a replication site!

Lawyers for Literacy Speak with Adult Learners

Local attorneys spent a morning sharing their passion for reading and how it has enriched their careers as they talked with classes of adult learners at the Adult Education Center in West Palm Beach. The adult students were motivated and encouraged by the attorneys to continue their studies and to persevere through many hardships to achieve their goals and dreams.
